What Happened to the Lights? by William Morrison

Every so often electric utilities will have a generator have problems or a power line have an unexpected interruption. Those occurrences are referred to as "forced outages." As would be expected, a utility takes steps to not have forced outages. One way is to have scheduled maintenance outages so that the consequences of any "down time" is kept to a minimum.

Alameda Municipal Power (AMP), is scheduling an outage to replace a power pole that is in danger of failure due to age and deterioration. Often AMP can work around the outage, but this time the pole distributes power to a number of blocks in the Fernside area.

On Tuesday August 18th, AMP will deenergize the line that serves the southside of Gibbons (even number houses) and the northside of Bayo Vista and Southwood (odd number houses) from the intersection of Southwood and Gibbons to High Street. The lights go out at 09:00 and are expected to be that way for probably ten hours.

Affected residences should have received a door hanger. Hints to prepare for the outage are on the back side of the notice.



Anybody Notice the Sidewalks? by William Morrison

Alameda's Department of Public works (DPW) has recently reduced the trip hazards of our uneven sidewalks. The DPW is using concrete planing to take off the rough edges between concrete sidewalk blocks.





(depicted are two different sidewalks left: uneven. right: shaved)

The program is less expensive than breaking up the uneven blocks and reinstalling the damaged sidewalk. Not all of our uneven sidewalk is a candidate for planing, but with the reduced cost more repairs and corrections can be accommodated.

[Editor's note: that happened in the 3100 block of Bayo Vista Avenue, 1800 block of Cornell Drive, along Pearl and Moreland, and more Workers smoothed out where one concrete square or edge was higher than an adjacent section. Unfortunately the sidewalks along Gibbons Drive are not candidates for that treatment.]

Also they plan on changing the intersection of Tilden Way at Fernside Blvd/Blanding Avenue. Any changes to that intersection would impact vehicle traffic on Blanding Avenue, Tilden Way, and Fernside Blvd.
